PAST YEAR TUITION MUST BE PAID IN FULL TO GUARANTEE ENROLLMENT

Payments more than 30 days past due may be referred to the Principal.

Continued payment delinquency may render the student ineligible for continued enrollment and may result in referral of the account to third party collection agencies.

Withdrawal Policy

Upon written notification to the principal of student withdrawal, families will be responsible for tuition according to the following schedule:

Prior to the first day of school	10%.
Prior to October 1st	25%.
Prior to December 31st	50%.
After December 31 st	100%.
